The total annual amount contributed through your company's payroll giving campaign will determine your Corporate Sponsorship level and associated recognition benefits. Even small recurring gifts create significant impact:

\$5 per paycheck = approximately \$130 annually

\$10 per paycheck = approximately \$260 annually

\$20 per paycheck = approximately \$520 annually

\$50 per paycheck = approximately \$1,300 annually
